October 16, 2019 Request for Proposals Single Stream Recycling Services and/or Green Waste Disposal

The City of Cape Girardeau is soliciting proposals from interested entities to enter into a contract for single stream recycling services and/or green waste disposal. Entities may submit proposals for either single stream recycling services, green waste disposal, or both.

The selected entity will coordinate with the City's Public Works Department. The City will entertain and evaluate all qualified and deemed appropriate proposals that meet specified criteria as outlined in this *Request for Proposal (RFP)*. Qualified entities will have a demonstrated, successful business record with references available for evaluation. The City reserves the right to accept any, all, or part of a proposal for potential partnership consideration.

OVERVIEW OF CAPE GIRARDEAU

Cape Girardeau encompasses approximately 29 square miles, serves an approximate population of 39,000, and operates under a council/manager form of government. The City offers weekly curbside single stream recycling pickup as well as a recycling drop off center at the Public Works facility located at 2007 Southern Expressway. Recyclable materials average 236 tons per month and are a mixture of residential and some commercial hauled single stream material. Cardboard is collected and averages 72 tons per month. Cardboard, though collected separately, for the purpose of this RFP shall be included in single stream materials. In addition to single stream recycling pickup, the City offers curbside leaf pickup from October through March and storm debris pickup when needed. Residents may also bring green waste year round to the drop off location at the Public Works facility. Proposals shall include entities providing trucks, trailers, operators, and containers and hauling single stream recyclables and cardboard from Cape Girardeau's Transfer Station located at 2055 Corporate Circle and/or green waste from the old Transfer Station located at 2500 S. Sprigg Street to the entity's processing location.

RFP SUBMITTAL OVERVIEW

Interested entities will need to meet the following minimum criteria and the proposal should include:

- 1. Entity name, key contact, including any partners or sub-companies, and the titles and roles each will play in the process;
- 2. Documented experience in the recycling industry with a successful business record, including two references (contact person, phone number, and address);
- 3. Demonstration of understanding of the City's recycling needs;
- 4. Describe the proposed services including the end use of the recyclables and/or green waste. Recyclable material shall not be landfilled but shall somehow be reused, repurposed, etc.;
- 5. Proposed use of the City's old Transfer Station. The City is making available the old Transfer Station for use in single stream recycling and/or green waste disposal.



Currently, all green waste is stored on the old Transfer Station site until it is mulched and hauled away. The City reserves the right to occasionally use a portion of the old Transfer Station floor to dump recycled glass and load it into trailers, a process that typically takes two days. Recycled glass is excluded from this RFP. Entities proposing to use the old Transfer Station site are responsible for any permitting required by the Missouri Department of Natural Resources or other organizations. The old Transfer Station site is subject to Mississippi River flooding. The City has taken measures to mitigate severe Mississippi River flooding (constructed a levee), but minor interior stormwater flooding can be an issue when the Mississippi River is above flood stage. Use of the City's old Transfer Station is not mandatory;

6. Proposed implementation schedule, financial scenario, and longevity of partnership between the entity and the City.

The Request for Proposal must be received by the City of Cape Girardeau's Development Services Division, on or before 4:00 pm (local time) on Wednesday, November 20, 2019. An original plus four copies (a total of five) of the RFP must be submitted. SELECTION PROCESS

The City will appoint a Selection Committee to evaluate each submission according to the selection criteria listed in the following section. If necessary, the top two or three ranked entities (short list) will be invited to make a presentation of its detailed proposal, qualifications and expertise as it would apply to single stream recycling services and/or green waste disposal. The Selection Committee will score the short listed entities using the same selection criteria as the initial evaluation. The highest ranking entity(ies) will be asked to enter into final negotiations as applicable, with the City for the purposes of a contract award and City Council approval.
